On 12-03-14 I was approached by Lt Stock who advised me to contact Jack Berry in reference to some emails he received in reference to an add on Craigslist that he did not post. It was further stated that an unknown person had posed as the Lake Shore Hospital Authority, and inturn numerous responses were received.

I made contact with Jack and he advised that he had received emails from persons offering to help him create a web page. During this time he told me that he had learned that there was an add on Craiglist and the emails he got were in response to that. I was then told that he contacted Craigslist and requested the "post" be taken down.

I later looked on line and could not find the post itself. I then emailed Craigslist and asked about the post. I got a

response back that said per a request the add was taken down. I then asked if the origin had occurred in Lake City, Florida. A response has yet to be received. I later spoke to Jack Berry and he was advised that the post had been removed. I was told that he would like to know the origin. I then articulated that charges would ultimately be sought if a suspect was identified.

I had sent response emails to Craigslist again asking if the post in question originated in Lake City, or Florida for that matter. No response was ever received.

On 12-31-14 I drafted a subpoena and mailed it to the legal department of Craigslist located in San Francisco, California. After 10 working days or so, I got a response that indicated the post in question was from an "area description" of North Central Florida, the "geographic area" was listed to be Lake City, and a "poster ip" of 66.177.60.144

I then made a further queries and it was discovered that the ip number originates from Comcast Cable. I made contact with local employees at Comcast who were able to provide information for their legal department in Moorestown, New Jersey.

On the 21st of January I sent a subpoena to Comcast for any information associated with the ip address previously listed.

On the 28th of January a fax was received that advised the subscriber name was identified as Barbara Lemley, and her local address was also provided.

On January 29th I went to the State Attorney's office and had a meeting with several attorney's. As this incident was discussed it was revealed that the incident at hand is within the criteria of "cyber stalking"

On January 30th Myself and Investigator Cox responded to the home of the Lemley subject. I identified myself and Inv Cox as Investigators from the Lake City Police Department. I then explained to the Lemley subject that I was working a criminal case and that I need information from her. I was told that she was "on the phone" I then explained that I could wait. I was then told that she had to leave as she has rental properties and that there was a "plumbing issue" I advised that I could come back later, and I was told that she was going "out of town" I then advised her that I would return on Monday the 2nd

On February the 2nd Myself and Investigator Useche responded to the home of the Lemley subject. I made contact with her in her driveway and explained that I needed five minutes of her time. I advised her that I was working a case that involved a subject named Jack Berry. I then openly told her that she knew him. As I started to talk about the incident in more detail she advised that she had "nothing to say" As a result of her statement no further questions were asked.

On 02-04-15 I made contact with the Jack Berry subject and he was advised of my findings. I was then told that after considering the facts, he felt the best way to address the issue at hand, was present this matter to the Board of Trustee's and that they would vote on whether or not they wanted to have this matter forwarded to the State Attorney's office for review. I was advised that the final decision should be made by the board and not an individual.

Affidavit is pending . No further information is available.
